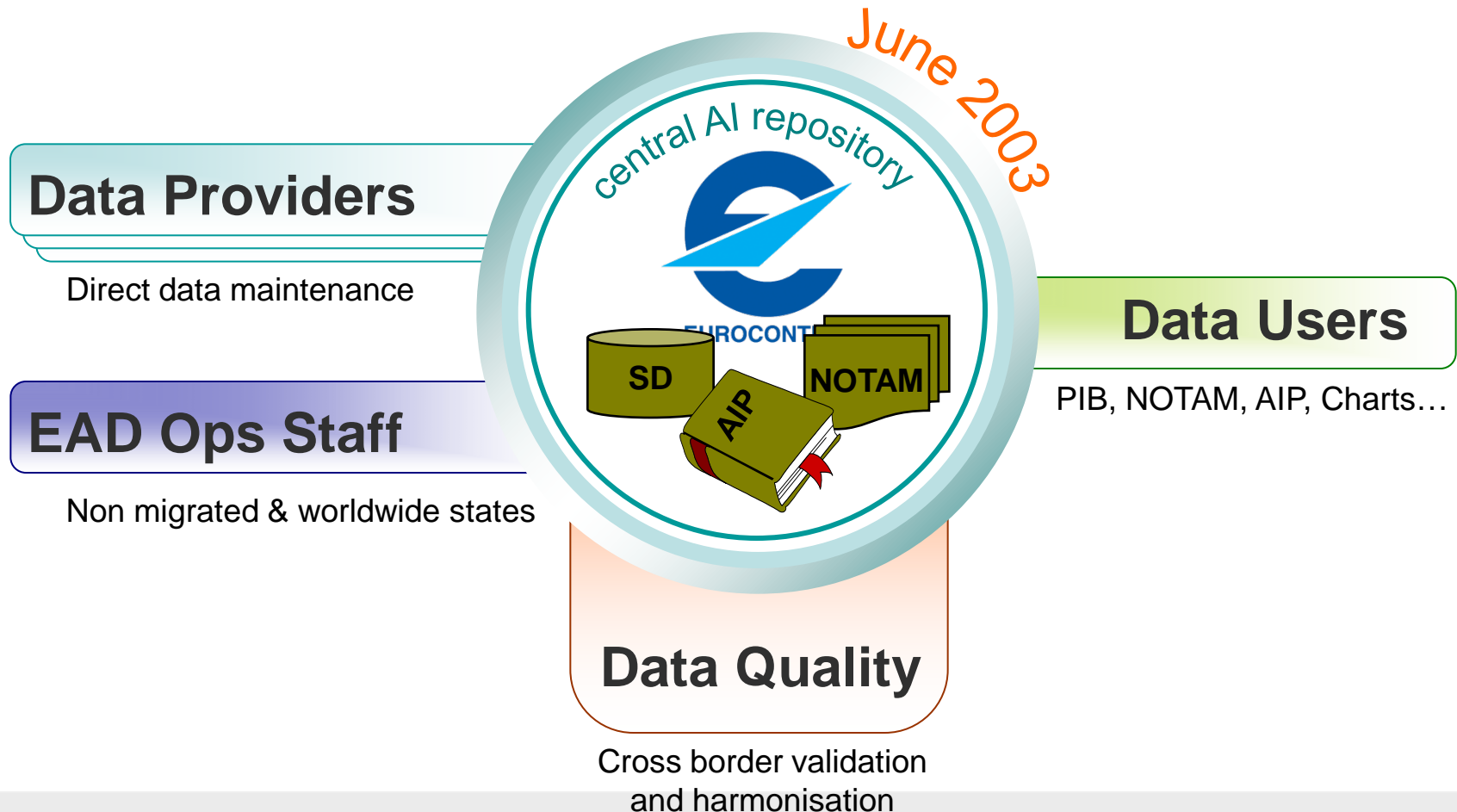
Principles

- EUROCONTROL operates and manages the EAD on behalf of its Member States, and provides a system/service to AIS Providers supporting the delivery of AIS Services as defined by ICAO Annex 15
- States remain responsible for providing the AIS and the information published. AIS Providers of migrated States (Civil & Mil) are responsible for inserting, maintaining and correcting their national data directly in the EAD
- Provision of the EAD IT, Data Operations and Training services are contracted to private Service Provider



Concept

- EAD is a service provided and owned by EUROCONTROL on behalf of its Member States – *PC Decision n° 83 ~ July 2000*





Operational Areas

- **SDO** – Static Data Operations
- **INO** – International NOTAM Operations (Worldwide)
- **INO BF** – ARO Briefing Facility (Worldwide)
- **PAMS** – Published AIP Management System (ECAC)

Additional

- **eAIP** – Electronic AIP production using SDO
- **CHP** – Chart production using SDO



Available Data (1)

Static Data Operations (SDO)



- **AIP data in AIXM Format**
 - AIXM 4.5 legacy system
 - AIXM 5.1 full data exchange available since Jan 2016

- **Currently 30 ECAC States fully migrated**
 - Remaining States to complete in 2016 & 2017

- **EAD Data Catalogue (based on ICAO Data Catalogue)**
 - Data Set Definitions
 - Min SDO (NOTAM validation, Pre-Flight Information Bulletin)
 - Full AIP (Annex 15 data)

 - More data sets under development
 - Based on User Requirements
 - CS5 EAIMS additional data

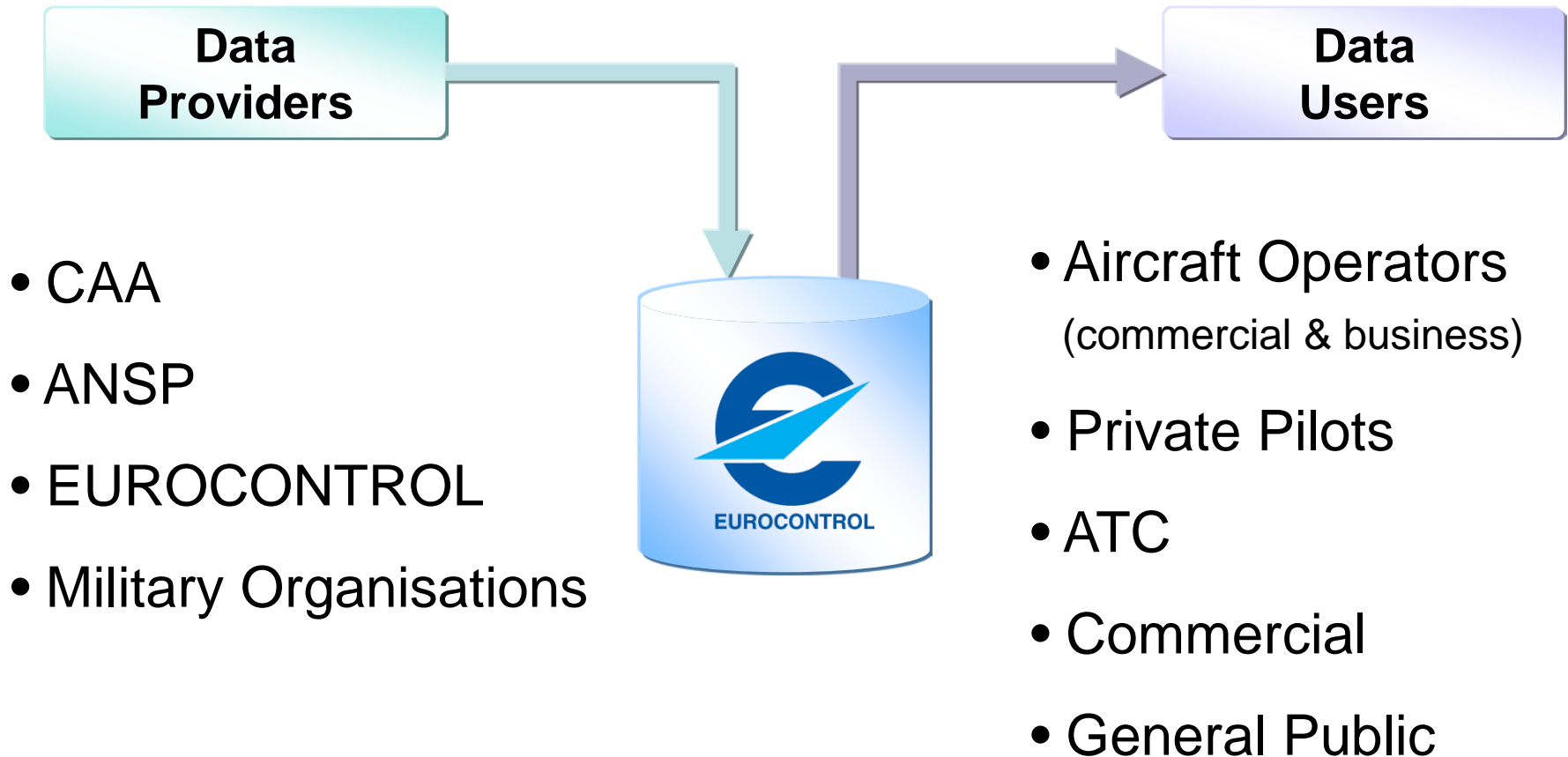

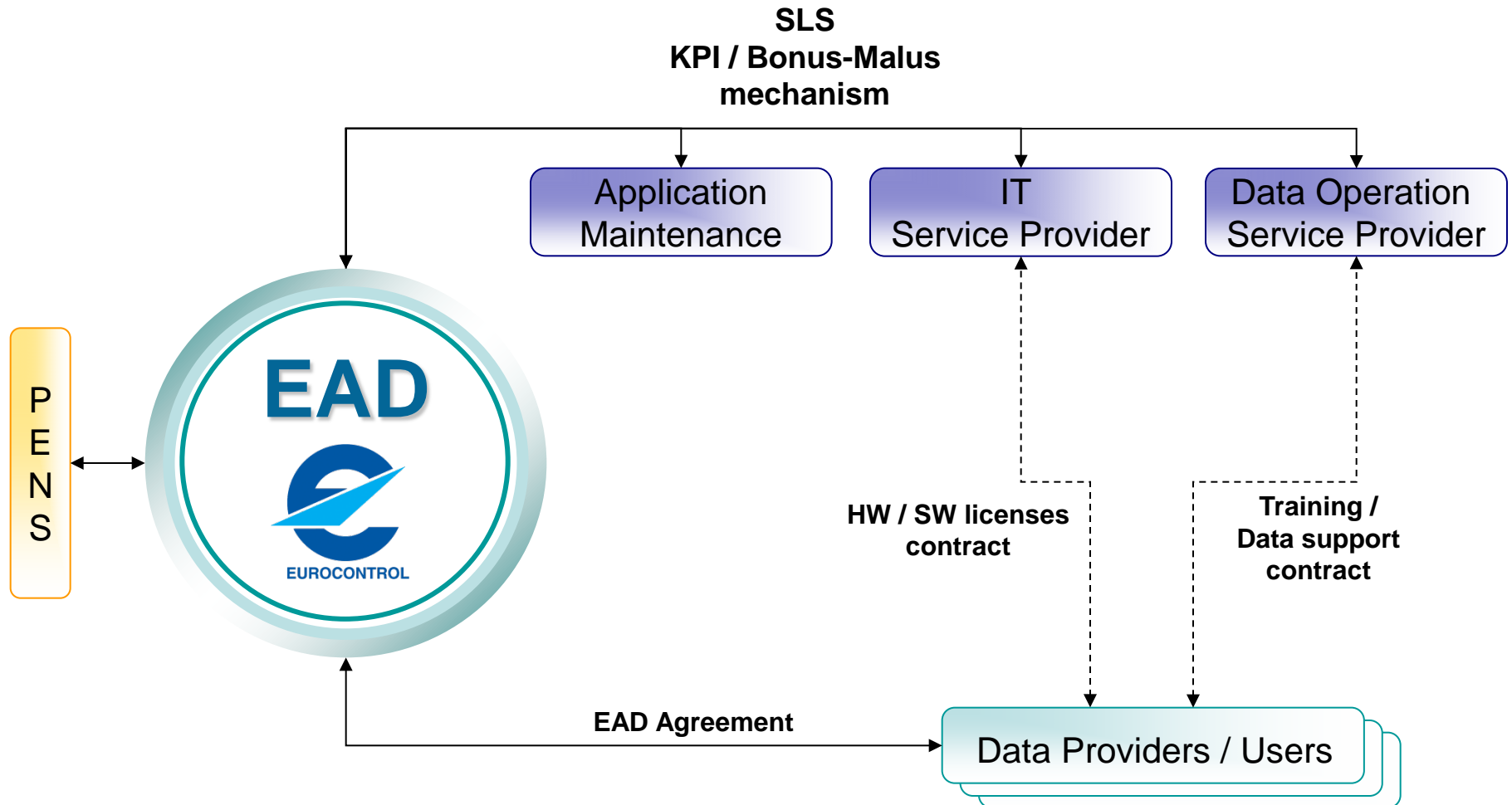

Contractual Structure

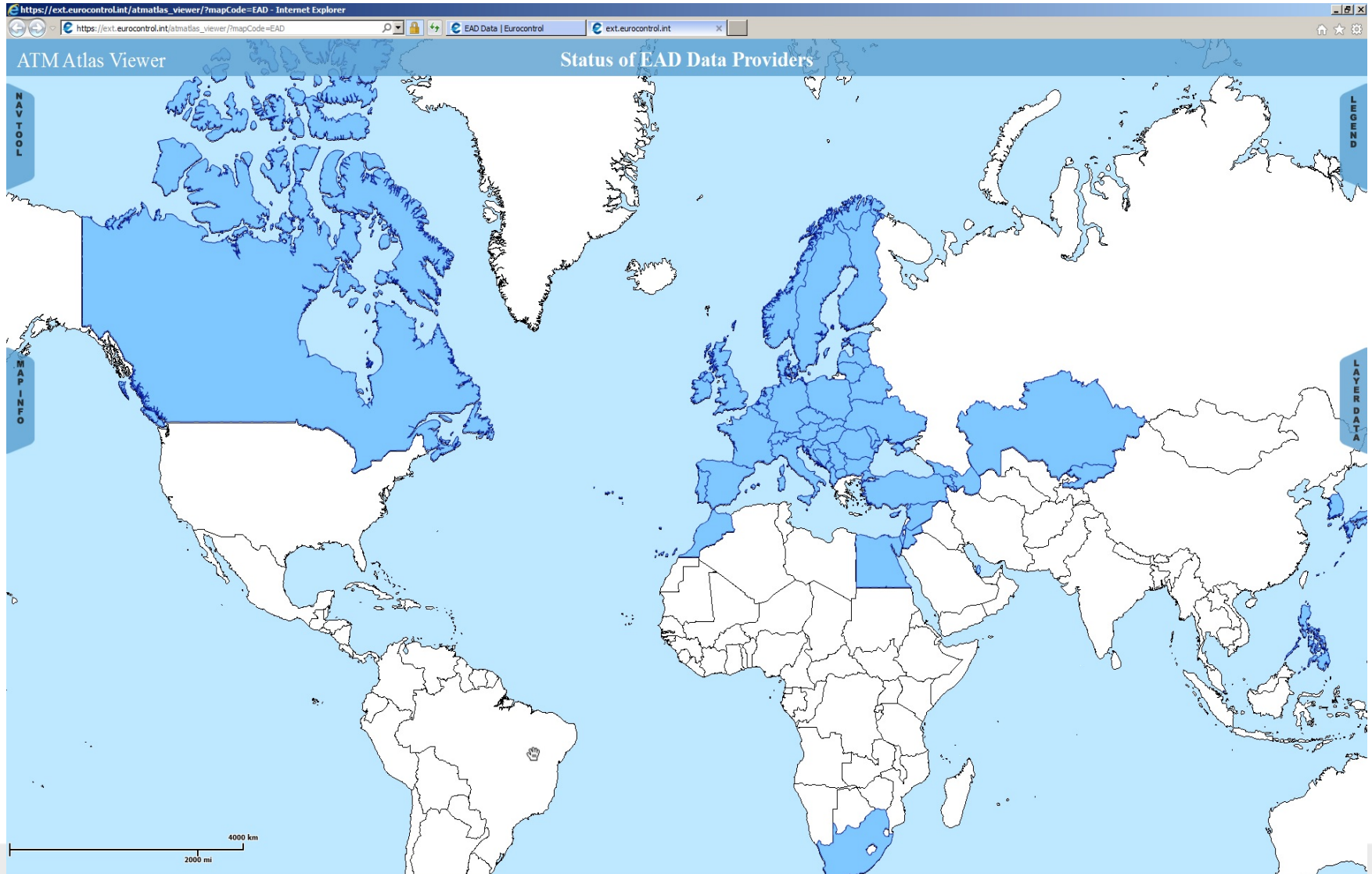

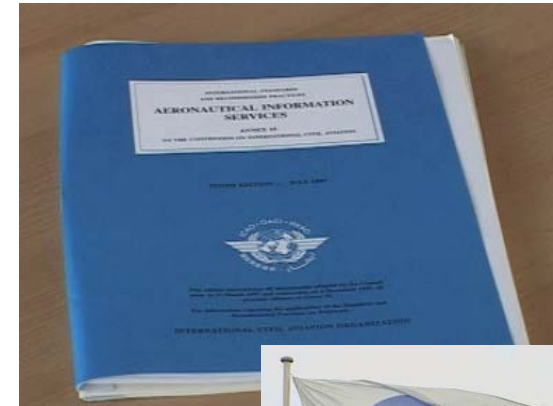

EAD ~ ADQ (EC) IR 73/2010

- **Data set and data exchange requirements**
 - XML, XML Schema, GML => [AIXM 5.1](#)
- **Data Quality requirements**
 - Supported through [Workflow Management Tool](#) (WFM)
 - Seamless data flow from origination to the responsible authority (ANSP, Data Provider)
- **Adaptation of processes + provided documentation.**
 - Tools and software requirements;
 - Assessment of conformity / suitability for use;
 - Requirements for verification of systems.



Implementation of AIXM 5.1 (1)

- **AIXM 4.5 legacy system**
- **AIXM 5.1 available**
 - Core Data is backwards mapped and stored in AIXM 4.5
 - SDO display/reporting/download only for limited b/w mapped data set
- **No equivalent in AIXM5.1 for tools that support AIXM4.5**
 - ARINC download – NM decision in the context of the EAIMS scope
 - Graphical Validation (but COTS products are available)





Implementation of AIXM 5.1 (2)

- **Reporting tool for AIXM5.1 provided**
 - only available through EAD Pro (not MyEAD/B2B or EAD Basic)
- **Lower priority on certain AIXM 5.1 packages and features not implemented yet**
 - Military Specific features (HMAI Project)
 - Features supporting AMDB
 - Features supporting Digital NOTAM (surface contamination etc.)
 - Surveillance package (radar)





Workflow Management Tool – WFM (1)

- **Commission Regulation (EC) IR 73/2010 ADQ**
 - Data exchange by direct electronic connection
 - Data protection & traceability on each data item
- **Implementation in EAD**
 - Support ADQ regulation compliance
 - Bridge the gap between Data Originators and Data Providers (AISPs)
 - Based on standard AIS procedures to facilitate usage by any AISP and their Data Originators
 - Customisation possibilities to on order to fit user needs





Workflow Management Tool – WFM (2)

- **Added values**

- Manual data entry restricted to Data Originator
- All data transferred via electronic means
- Traceability through the entire data chain and data lifecycle
- Automated data management process through workflow system
- Generic Metadata storage for all subsystems



- **Main Functions**

- Customisable organisation set-up with the tool
- Process monitoring/history
- Document management system
- Reporting facilities

- **Support, documentation, Service Desk, Training, Licensing**

- **Official application for EAD Certification provided to EASA and accepted on June 16th 2015.**
- Compliance Matrix received (Aug 2015)
- Phase 1 - Kick-off meeting (Sept 2015)
- Phase 2 - Initial Review (Oct–Nov 2015)
- Phase 3 - Detailed Document Review (Nov–Dec 2015)
 - Review of complete system: SM-, QM-, CM-, RM-processes & Oversight Management (i.e. EAD SSG, Change Control Board, Ops Manuals, etc.)
- Phase 4 – Audits (Jan-Feb 2016)
 - EUROCONTROL, IT Service Provider (Frequentis), Data Operations Service Provider (GroupEAD)
- Corrective Action Plans (CAPs) provided and accepted by EASA
- EASA Certification of EAD Service and Functions expected June 2016



Challenges (1)

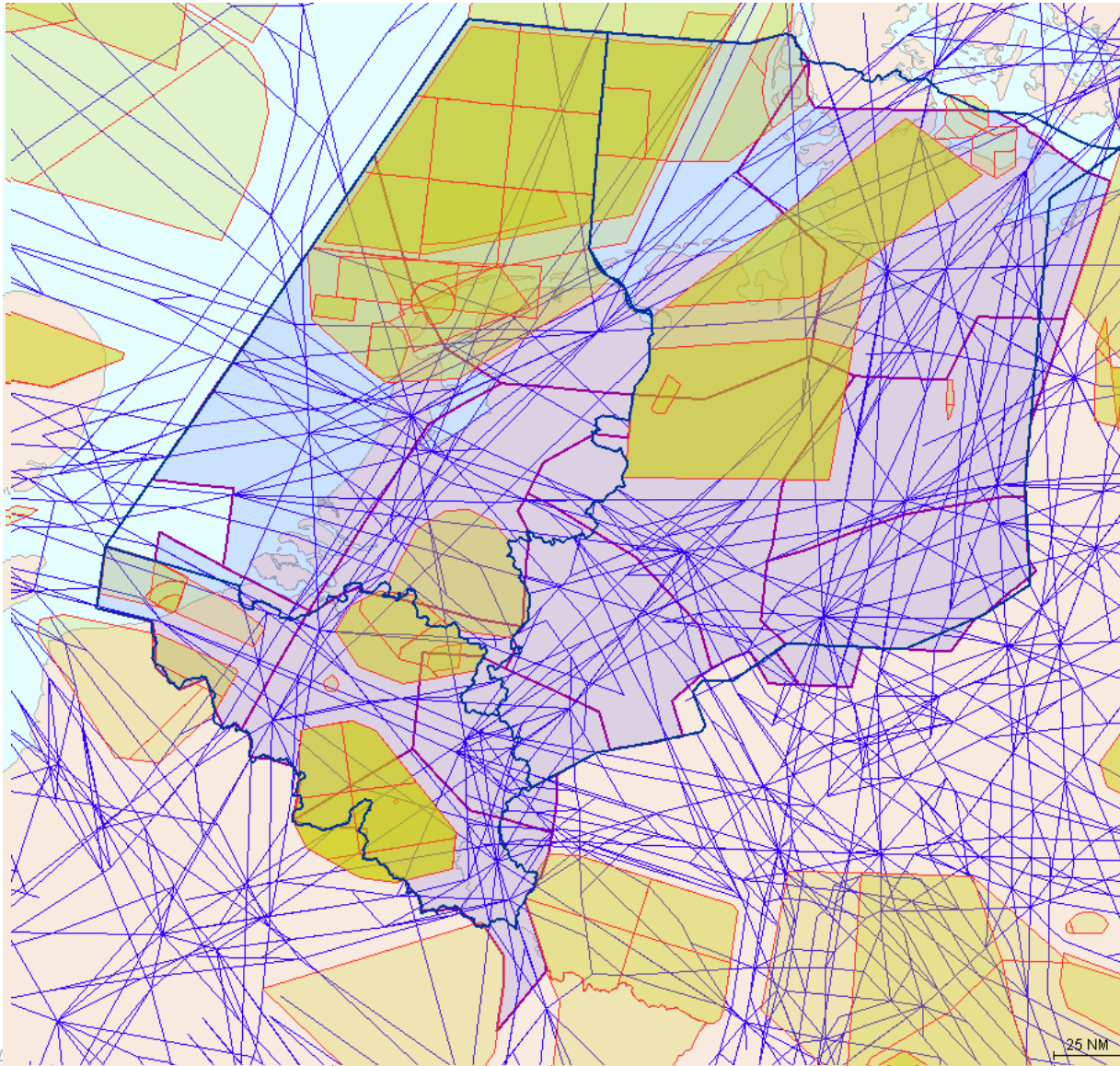
Free Route Airspace (FRA)

FRA is a **specified airspace** within which aircraft operators may **freely plan a route** between a defined **entry point** and a defined **exit point**, with the possibility to route via intermediate (published or unpublished) way points, **without reference to the ATS route network**, **subject to airspace availability**. Within this airspace, flights remain **subject to air traffic control**

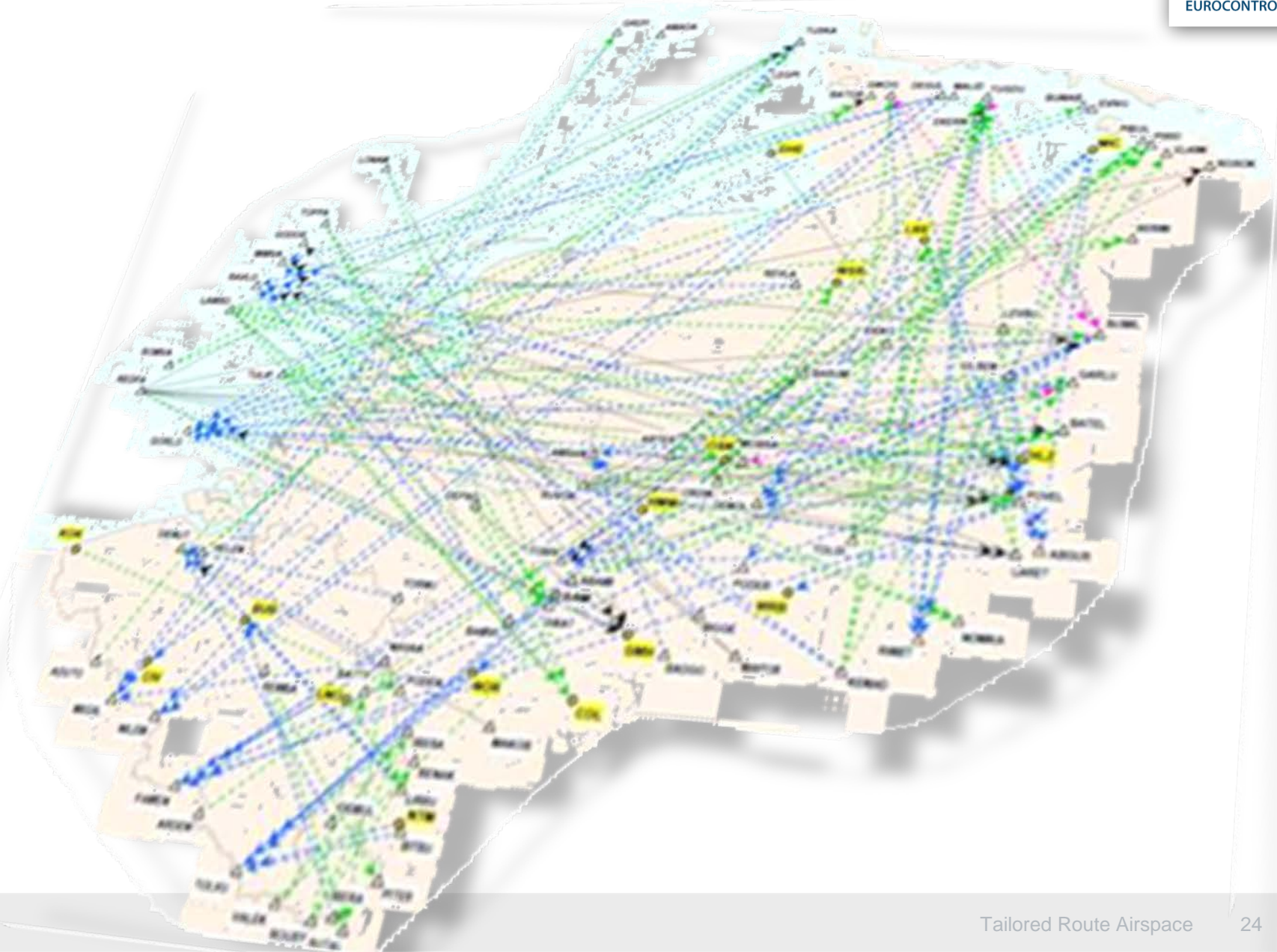

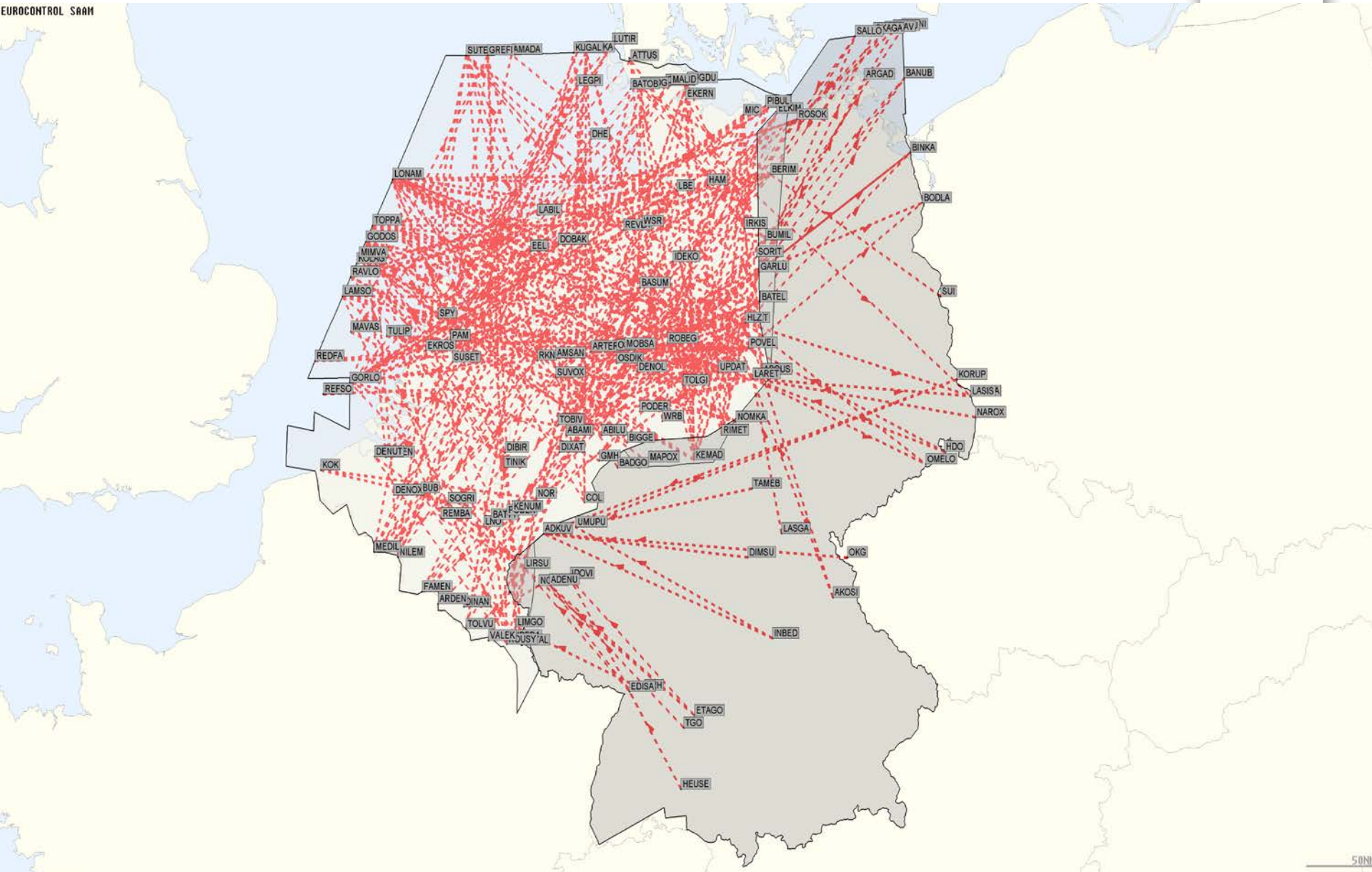

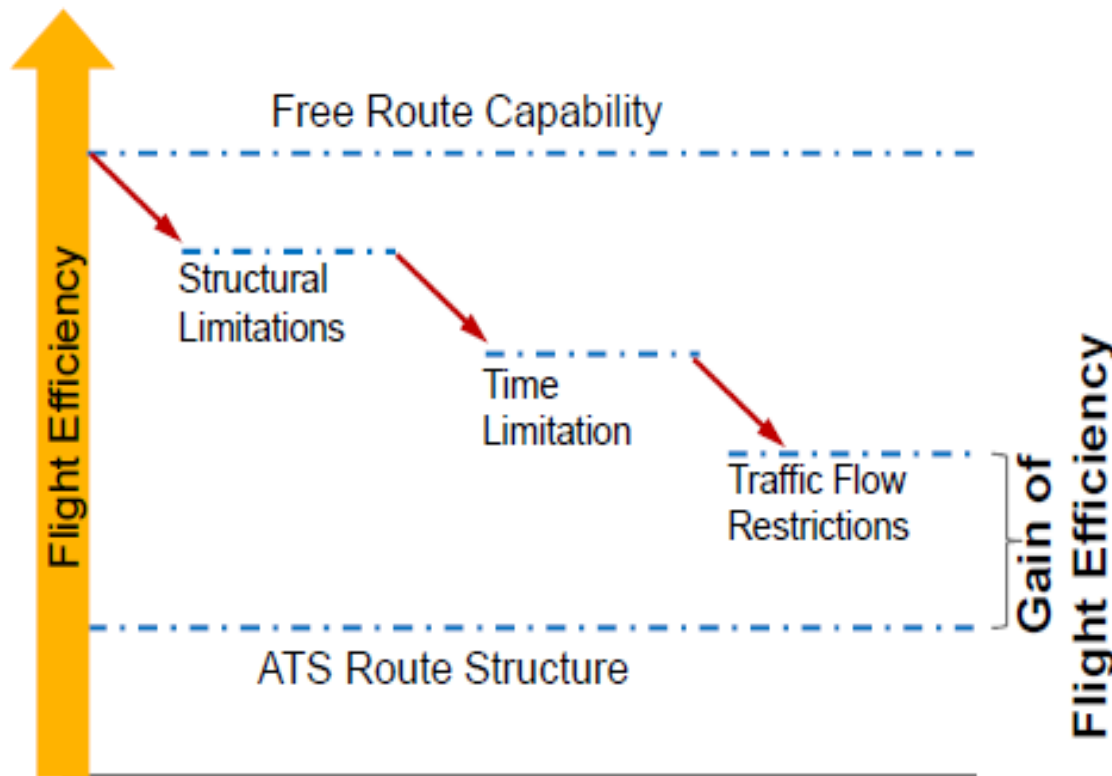

- Data Management Challenges

- Area of Responsibility (AoR) versus FIR/UIR
- FRA across 2 or more countries
- Sector Data corresponds to AoR rather than FIR/UIR
- Delegated ATS outside FIR/UIR are part of AoR



User Expectations

- Apply common FRA Design
- Implement large cross-border FRAs
- FRA data types/values in digital aeronautical data standards
- Maximum direct segment distance 250NM
- Minimum Safety Altitude above high mountains

Harmonised Data Model required together with clear defined Data Harmonisation Objectives such as EAD DH07



Challenges (2) Drones

- **Unmanned Aerial Vehicles (Drones)**

- About 360.00 aircraft worldwide compared to more than 4.000.000 drones already (increasing daily)
- Drone incidents with airplane increasing daily (near misses about 4 per day and raising)
- BA plane hit drone at Heathrow airport (spring 2016)
- KLM plane had a near-miss with a drone recently at Amsterdam airport
- Drone hinder rescue activities (blocking helicopter to land at accident site)

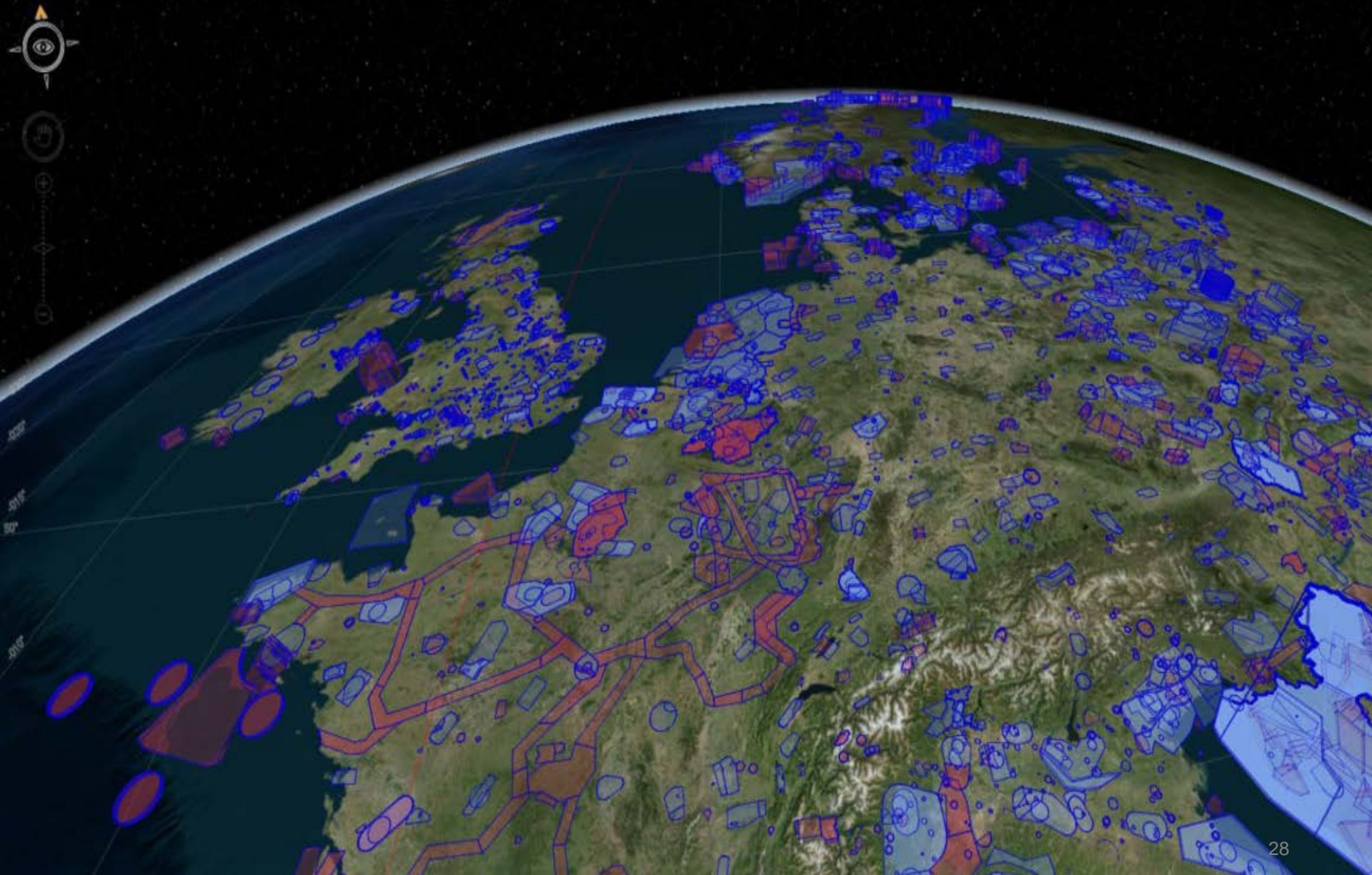


EAD is working close together with ANSPs, EC and industry to find and implement solutions in order to increase Safety!

Further Way Ahead (tech)

- **EAD Release 11**
 - Deployment planned for June 2017
 - New HMI for ECIT (B2C) Clients (Workshops)
 - ICAO Amendment 39 Requirements
 - System Performance Enhancements
- **European ATM Information Management Service (EAIMS)**
 - EAD+ (new state of the art System Architecture)
 - Enhanced Briefing Facility (digital NOTAM, WX, enhanced Graphical Display)
 - One single source for ATM data (Flow & Capacity data, Aircraft Performance Data etc.)
 - Deployment planned for winter 2020/21
 - CFT to be launched in Q2 2016



Strategic Vision (business)

- **EAD Royalty Charges**
 - The current EAD Royalty Charging Scheme needs to be reviewed
 - Royalty Charges should be applied for Commercial Data Usage
 - A first step has been made to develop a Credit Card Slot for the EAD Basic (Web Application) in order to simplify invoicing

- **Data Base “Hubs”**
 - Medium-. and Long -Term Strategy is the support of the creation of similar Data Bases “Hubs” worldwide
 - Connections (interfaces) to be established with EAD based on SWIM (yellow profile)
 - Data ownership stays in all cases with the Data Providers (Authorised Source)
 - Data Usage requires Liability Insurance in order to avoid that liability for “fine-tuning” of data is not pushed to Data Providers in case of incidents.

EAD Services Offered

EAD components available for Data Providers are:

- SDO - Maintenance, download and reporting of static data;
- INO - Creation and retrieval of NOTAM;
- PAMS - Publication and consultation of aeronautical documents;
- AIP - AIP Production
- CHART - Chart Production

EAD components available for Data Users are:

- SDO - Static Data Operation for Data Users
- INO - Additional NOTAM Operations for Data Users
- PIB - Generation of Pre-Flight Information Bulletins;
- INO Briefing Facility for ATS Reporting Offices (ARO)
- PAMS - Published AIP Management System for Data Users

Additional Services

In addition to the availability of the operational AIS data, clients can take full advantage of:

- 24h/day service availability: professional staff work around the clock to process AI and to provide a client Service Desk;
